**APPLICANT:** Cork and Bull Restaurant Inc.

**NAME and ADDRESS OF PREMISES:** Dirty Northern Public House and Miner's Daughter Eatery – 103 Main Street Whitehorse, Yukon Y1A 6K6

**NATURE OF APPLICATION:** Extension of hours of liquor service and approval in principle for the addition of an external patio.

### **CURRENT LICENCES:**

- Food Primary (Currently operates 10:00 AM – 10:00 PM)
- Liquor Primary (Currently operates 10:00 PM – 2:00 AM)
- Off Premises Liquor (Currently operates 10:00 AM – 12:00 AM)

**NUMBER OF LICENSED PREMISES IN THE AREA:** There are currently 41 Food Primary – All Liquor, 17 Liquor Primary – All Liquor, 30 Off Premises Liquor, The closest licensed premises is Tonimoe's located at 101 Main Street. They hold a Food Primary – All liquor licence and an Off-Premises Liquor licence. The closest Liquor Primary liquor licence is held by the Social House, which is located at 102 Wood Street.

### **ISSUE CONSIDERATIONS:**

#### **A.) STRUCTURE/PREMISES:**

The premises is in a two storey wood frame building located at 103 Main Street in Whitehorse. The Miner's Daughter Eatery occupies one side and the Dirty Northern Public House occupying the other side.

The applicant proposes to extend their hours of liquor service to the following licences:

- Food Primary liquor licence - from 9:00 AM to 10:00 PM.
- Off Premises Liquor Licence - from 9:00 AM to 2:00 AM.

The applicant is also seeking approval in principal to licence a new external patio at the front of the building. The location of the new patio being considered is on the sidewalk or in the parking spaces in front of the Dirty Northern Public House portion of the business.

**B.) MENU:** Miner's Daughter Eatery offers western style cuisine such as steak, salads, sandwiches and desserts.

#### **C.) HOURS OF BUSINESS & HOURS OF LIQUOR SERVICE:**

The business hours are 9:00 AM – 2:00 AM. The proposed hours of service requested are: Food Primary - All liquor licence - 9:00 AM – 10:00 PM, Liquor Primary licence 10:00 PM – 2:00 AM and the Off Premises Liquor licence - 9:00 AM to 2:00 AM 7 days a week.
