## Are you planning to sell your business?



If you are planning to sell or lease out your business, you and the person taking over need to know that the transfer of the liquor licence is not automatic. You must advise us at least 30 days before the proposed effective date of any change in ownership (&/or corporation or partnership arrangements). The new owner (or lessee) is required to complete an application for transfer and the processing of this transfer takes time.

Neither the warehouse nor rural liquor stores can release liquor orders to new licensees until all documentation is in order and a new licence has been issued. To ensure a smooth transition, please contact the Licensing Branch well in advance.

## Private Parties in Licensed Premises



You can allow someone to reserve your entire premises for a private party.

During any private party, all the terms and conditions of your licence still apply (access by minors, capacity, hours of operation, intoxication, etc.)

Please give the event information to Yukon Liquor Corporation in writing no later than ten days before the event, so we can plan our inspections accordingly.

**Time to FALL BACK**

Daylight Savings Time ends at 2 a.m. on Sunday, November 6. Set your clocks back one hour after closing on Saturday night – but remember, you don't get to keep serving or stay open for an extra hour!

November 7, 2011 marks the 24th annual launch of the MADD (Mothers Against Drunk Driving) Project Red Ribbon campaign.

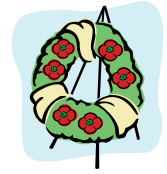
Last year, millions of motorists across Canada tied MADD Canada's red ribbons to their vehicles to pledge their commitment to drive safe and sober.

The red ribbon also serves as a memorial to all those killed or injured by impaired driving.

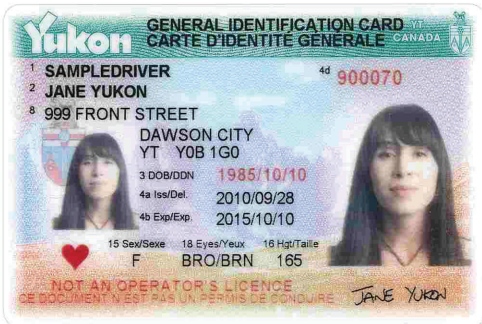
MADD Canada's mission: to stop impaired driving and to support victims of this violent crime.

Red ribbons and donation boxes will be available at all Yukon Liquor stores until January 2, 2012.

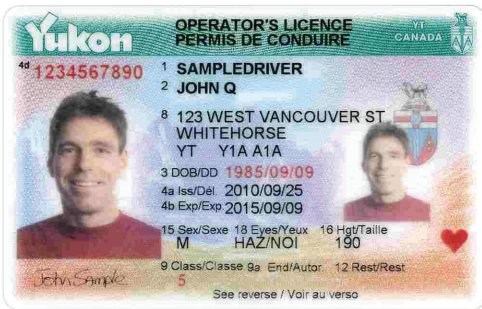

## Liquor ID's No Longer Valid



### General Identification Card



### Operator's Licence

As of November 1, Yukon Liquor ID is no longer an accepted form of liquor identification.

Refer to your *Yukon ID Proofing Guide* to show you what security features you should be looking for. If you require more copies, contact the Main Office.

Backlights and small inexpensive magnifying glasses (to check the micro printing) would be useful for your staff.

**Note:** Bar code on the back is for the use of law enforcement ONLY.

## Clearing Premises



A liquor primary premises must be closed to and cleared of all person, except for the licensee, the licensee's spouse or on-duty staff, 30 minutes after the sale of liquor ends, as stated on your liquor licence. For example, if your hours of sale end at 2:00 am, all guests must be out of your establishment by 2:30 am. Although we realize staff may need to stay to cash out and finish their clean up after all patrons are cleared, we expect that staff will then leave the premises within half an hour after closing.
